Organisation

Jami is a mental health charity that enriches and saves lives impacted by mental illness and distress in the Jewish community.

Since the start of the pandemic, demand for our services has grown exponentially. In 2021 we undertook a thorough review of the needs of the community, to develop a new strategy that will secure the Jewish community's mental health provision. The new strategy sets out a huge agenda for change in scale and provision, which will be developed over the next five years while we continue to run our diverse set of highly professional mental health services:

- Advice and advocacy
- Treatment and support
- Education and campaigning

Jami currently supports over 1,400 individuals, delivering almost 50,000 separate service interactions each year, and reaches thousands more people through education, seminars, work in schools and other organisations. Through our social enterprise community café, Head Room, we raise mental health awareness while delivering mental health support on the high street.

Job Purpose

To be responsible for the running of the kosher kitchen at Jami hub, including food preparation, stock maintenance and food safety. Maintaining a welcoming and open environment for Jami service users.

Responsibilities

- Keep kitchen kosher and compliant with Kashrut
- Management of daily operations, kitchen costs and food preparation
- Fill urn and make sure tea/coffee/sugar supplies are refreshed
- Ensure tablecloths and tea towels are washed and ready for use
- Fill and empty dishwasher
- Make a 2-week healthy food plan for 10-15 people
- Determining food inventory needs, stocking and ordering
- Keep Daily/weekly worksheets
- Clean out fridge each week
- Take temperatures of fridge and freezers daily
- Ensure pantry is kept clean and tidy
- Responsible for ensuring the kitchen meets all regulations including sanitary and food safety guidelines
- Being responsible for food hygiene practices
